ENQUIRY COMMITTEE REPORT

Enquiry Committee constituted by Principal, K.V.G. Dental College & Hospital, Sullia, held enquiry on 26-12-2022 at 10.00 in board of K.V.G. Dental College & Hospital, Sullia.

Compliant :

1. Written compliant from Dr. Visakh G Panicker, P.G. student of Orthodontics, dated 22-12-2022.
2. Complaint over the phone to the Principal by Dr. Pallavi N P, P.G. student of Oral & Maxillofacial Surgery on 21-12-2022.

Complaint Details :

Regarding physical assault by P.G. Students on 21-12-2022 at 10.30 p.m. at Spandana paying guest house Kurunjibag, Sullia.

Preliminary Enquiry Report :

The enquiry committee of KVG Dental College & Hospital, Sullia, conducted an enquiry in to the above alleged incident. It was on 21-12-2022 at above 10.30 p.m. a phone call received by Principal from Dr. Pallavi N P and her brother informing physical assault by another PG student. Principal immediately informed Administrative Officer and other concerned staff members to rush to the spot. Later another phone call received by Principal by Dr. Pallavi N P's brother stating that we have resolved matter by ourselves. Dr. Revanth Soonthodu, Reader in department of Orthodontics received a phone call stating that one of our PG student (Dr. Visakh G Panicker) was badly hit and bleeding from head and taken to K.V.G. Medical College & Hospital, Sullia casualty department. Concerned staff member rushed to the Hospital. Preliminary examinations and treatment for injury to Dr. Visakh G Panicker done in hospital. Search for Dr. Pallavi N P made by staff members but not found in campus or near by hospitals. Mean time Principal received a call from Dr. Pallavi N P at around 1.45 a.m. on 22-12-2022 stating that, "I will come tomorrow with documents".

On 22-12-2022 Dr. Visakh G Panicker submitted a written complaint regarding physical assault on him and he was seen with forehead sutured wound and bandages there was. Letters received from PG students of Oral & Maxillofacial Surgery and their parents regarding misbehavior of Dr. Pallavi N P and her brother. They also expressed their concerned over their safety. On 22-12-2022 Principal held HOD

meeting regarding the incidence and preliminary enquiry done. Principal informed that on 20-12-2022 Dr. Pallavi N P and her brother met her in Principal chamber. Dr. Pallavi's brother stated that she is taking medication for depression. Our management Dr. Jyothi R Prasad (Renowned physician) reassured them and suggested to slowly taper the anti depressant drug after taking psychiatrists opinion.

On 23-12-2022 at 10.30 a.m. meeting with Chief Executive Officer held at Principal's chamber. An enquiry committee was constituted. Enquiry notice sent to stake holders by email.

Enquiry held by committee on 26-12-2022 at 10.00 a.m. board room of KVG Dental College & Hospital.

Following persons appeared.

1. Dr. Visakh G Panicker, PG student of Orthodontics
2. Dr. Haneesh Kiran P T, PG student of Orthodontics and his mother, mothers brother.
3. PG students of Oral & Maxillofacial Surgery - Dr. Dannel Sebastian, Dr. Dhaya Ann Varghese, Dr. Alpha Mary Mathew, Dr. Rishikesh Kumar, Dr. Ishwarya R
4. Mr. Zyed Bin Hazeel, Intern, KVGDC, eye-witness for the incidence.

Statements of above persons were recorded. However Dr. Pallavi N P did not present herself in front of committee members to record the statement.

Findings of the committee as follows :

1. The alleged physical assault incidence happened outside college and outside campus premises.
2. The incident happed between two PG students Dr. Pallavi N P and Dr. Visakh G Panicker in Spandana paying guest house premises.
3. Dr. Haneesh Kiran P T and outsider (Dr. Pallavi's brother) were involved in the incidence.
4. Pending enquiry, committee members recommended to suspend the involved PG students Dr. Visakh G Panicker, Dr. Haneesh Kiran P T and Dr. Pallavi N P
5. It is come to the notice of enquiry committee that both parties registered compliant Police station.


Respected Sir / Madam,

Myself Visakh G. Panicker third year post graduate in the department of orthodontics, KVGD, Sullia writing this letter to inform a physical assault happened to me on 21/12/22 at 10:30pm at Spandana PG behind IPS. The incident was like I and my friend was driving back to his PG to drop him, one delhi registration innova car was chasing till the PG. From that my batchmate Pallavi, her brother, my COPG Itaneesh and one member from their group whom I have not seen came towards me and started holding my collar asking why did you threatened my sister. I being not knowing what's happening there, I told them "I haven't done anything, I didn't do anything." Meanwhile Pallavi came from nowhere and slapped on my face and started using swears, second time when she was about to hit, I defended myself raising hand as a self defence, that time her brother started shouting "how dare you raise hand on my sister, how dare you touch my sister, I will kill you and barged on to me. Meantime my friend was telling "don't do, don't do" they didn't listen. By the time the 4th member went and took the Jackey lever of the car to hit me and started to hit me around my body and I was being held

by her brother on one side and when I ran towards other side, Pallavi and Haneesh came on the other side and pallavi was throwing chappal at me and started hitting with the chappal. I ran to save my life from them they ran towards me, Pallavi threw chappal again and haneesh and the driver holded me for them to hit me with the jockey lever. I was full of blood and I started running away to save my life. Then my friend took me to hospital.

All this happened is just because I was being an eye witness for fight between my friend abaya and pallavi.






